The following outlines the privacy policy, terms of use and disclaimer statement for the Hegg Memorial Health Center's Website. Please read the following policy, terms and disclaimer carefully.

This site has been created by Hegg Memorial for purposes of health education, health management and administration only and should not be used as a substitute for professional medical advice, diagnosis, treatment or care. To help you feel comfortable using this website, we have included the following Privacy Policy ("policy") to explain how Hegg Memorial, through various health management vendors, collects, discloses and protects the information you share with us.

To administer the Hegg Memorial online PreAdmission Center, it is necessary to collect personal information that can be used to identify or contact you.

All the data we collect is kept secure, in compliance with the Health Portability and Accountability Act of 1996, and the rules enacted under the Act now and in the future.

The information collected through Hegg Memorial's website may be used for the following purposes:

- To gather information needed to provide Hegg Memorial incentives to qualified participants.
- To assess the program and identify opportunities for quality and service improvements.
- To perform aggregate data analysis to support administration and enhancement of the health management and education activities.
- To support overall health education and health management, activities and products.

Non-personal information is also collected through the use of "cookies," small data files the website places in the browser file of your computer's hard drive. Cookies are used to ensure that you are the only one with access to your confidential health information by allowing us to quickly identify your browser to our server whenever you log onto the Hegg Memorial website. Cookies are not linked to your personally identifiable health information, but they do help make sure your session remains secure by maintaining an identifier unique to your session and logging you off the web site automatically after a certain period of time. Each cookie is deleted automatically after a set of time or when you close your web browser and, while most browsers automatically accept cookies, you may be able to change your browser setting to reject cookies should you choose to do so.

From time to time you may be asked to participate in program surveys to help us measure the effectiveness of the site and Hegg Memorial Health Center. Should you agree to participate, you may be asked to review and accept terms and conditions relating specifically to the use of the information you provide. This may include personally identifiable information. Those terms and conditions will be in addition to this policy, and may include sharing the personally identifiable information with a third party in order to process the survey results.
